**NOTICE OF THE SPECIAL MASTER REGARDING THE
PAYMENT PROCESS AND THE TIMING OF PAYMENTS
UNDER THE AMENDED SETTLEMENT AGREEMENT**

I have received numerous inquiries regarding the payment process and the timing of payments under the settlement. This Notice provides information in response to these inquiries.

The Flint Water Settlement Fund (the “Fund”) is under the control of the United States District Court. Money can only be taken out of the Fund with Court approval. No one else can access the Flint Water Settlement Fund. The lawyers, the City of Flint, elected officials and the State of Michigan have **no** authority or control over the Fund. The money in the Fund is invested as directed by the Court.

In the Fall eligible claimants will receive specific instructions on how to obtain their payment. Currently, no payment letters or requests for bank information have been sent out. You will not be asked to provide such information except in the official Flint Water payment portal that you will be given access to. That portal is

NOT yet open. If you have received a request for bank information related to the settlement, do NOT provide any information and contact the Special Master's office at (202) 420-2200.

Everyone involved in the settlement – including the lawyers representing claimants – is working hard so that payments can be issued as soon as possible in a fair and equitable manner in accordance with the requirements of the settlement.

As of August 25, 2025, 25,759 individuals have been approved for payment. Some individuals have been approved for more than one payment – such as a property claim and an injury claim. Of the total individuals approved for payment, 13,169 were minors at the time of the water crisis and 12,590 were adults (or businesses). If you are still missing a signature, you will be able to sign the documents at the time of payment.
