SUMMARY

On 12/20/2021 at approximately 1610 hours, I was dispatched to make phone contact with 15.243(1)(a) who is an advocate calling on behalf of 15.243(1)(3)(1)(a) reference a CSC. I was able to speak with both 15.243(1)(43)(1)(a) 15.243(1) stated she was groomed and repeatedly sexually assaulted by Lee Chatfield from 2010 to 2021 at multiple locations all over the state of Michigan, including her own residence in the City of Lansing. 15.243(1)(43)(1)(a) stated that this incident was part of an organized effort by Independent Fundamental Baptist Movement to manipulate, isolate, and rape 15.243(1). 15.243(1) stated that Lee also held the position of 15.243(1)(a) while the sexual assaults continued. I obtained statements from both 15.243(1) and 15.243(1)

VENUE

This incident occurred at multiple locations across the state of Michigan, but most recently, 15.243(1)(a)

DATE AND TIME

This incident occurred between late 2010 until June of 2021.

VICTIM STATEMENT (15.243(1)(a) 15.243(1)(a)

I made contact with the victim, 15.243(1) 15.243(1) via phone call. 15.243(1) was initially crying and expressed fear of Lee Chatfield. 15.243(1) stated she was first sexually assaulted by Lee Chatfield in late 2010. 15.243(1) stated at this time, she was attending 15.243(1)(a) 15.243(1)(a) which is associated with the 15.243(1)(a) 15.243(1)(a) 15.243(1)(a) by Lee's father, Rusty Chatfield. 15.243(1) stated Lee was her 15.243(1)(a) and was also her 15.243(1) 15.243(1) stated that she began babysitting for Lee. 15.243(1) stated she was often allowed to spend the night at Lee's house. 15.243(1) stated the first time she was sexually assaulted by Lee, she was at his residence which is at an unknown address in Alanson, Michigan. 15.243(1) stated Lee came downstairs while she was watching TV. 15.243(1) stated at some point during this incident, Lee sat at the top of the stairs and was blocking the stairway so that 15.243(1) could not leave. 15.243(1) stated she was standing on the stairs directly in front of Lee. 15.243(1) stated Lee began touching her all over her body, including her chest and in between her legs. 15.243(1) stated Lee continued to touch her for several minutes. 15.243(1) stated she was approximately 15.243(1)(a) at this time. 15.243(1) stated that Lee was also sending her lewd text messages and Snapchats. 15.243(1) stated that there were multiple incidents similar to this where Lee would touch her inappropriately, leading up to him eventually having non-consensual 15.243(1)(a) intercourse with her. 15.243(1) stated she was approximately 15.243(1)(a) when Lee had 15.243(1)(a) sexual intercourse with her for the first time. 15.243(1) stated this occurred at 15.243(1)(a) 15.243(1) stated this was Lee's parents residence at the time. 15.243(1) stated that the 15.243(1)(a) sex was so traumatizing for her that she is currently undergoing 15.243(1)(a) in order to recall and mentally heal from this incident. 15.243(1) stated that she has communicated to Lee numerous times that she does not want to have a sexual relationship with him through texts, calls, and in person. 15.243(1) stated that Lee ignored her efforts to tell him that he did not have consent to have sex with her. 15.243(1) stated that when she turned nineteen, she was forced by Lee to marry Lee's brother, Aaron Chatfield. 15.243(1) stated that on the night before her wedding, she was upset because she didn't feel ready to marry Aaron. 15.243(1) stated that Lee observed that she was crying, then grabbed her by the wrist, pulled her into a closet, and forced her to give him a 15.243(1)(a) 15.243(1) stated that when Lee was finished, she told her "don't worry, I will talk to Arron, you guys are going to get married". 15.243(1) stated that Lee also made multiple trips to visit

her while she was in Illinois and Indiana for college. 15.243(1) stated that she was coerced into having sex with Lee and felt like she could not say no to him due to his position of authority over her, and also due to him ignoring her previous attempts to tell him no. 15.243(1) stated that approximately five years ago, she and Aaron moved to Lansing. 15.243(1) stated she and Aaron moved to Lansing because Aaron began working as a 15.243(1)(a) to Lee, who worked for the 15.243(1)(a) in Lansing at the time. 15.243(1) stated that Lee had access to and control over Aaron's schedule. 15.243(1) stated that at some point, Lee came over to her residence while Aaron was gone and said "let me up". 15.243(1) stated that when she told Lee no, he said "I will get to you before Aaron gets to you". 15.243(1) stated that Lee had sexual intercourse with her inside her apartment without her consent. 15.243(1) stated this happened multiple times. 15.243(1) stated that Lee would sometimes not use a condom. 15.243(1) 15.243(1)(a) sexually assaulted by Lee. 15.243(1) stated the child was born on 15.243(1)(a) 15.243(1) stated she will be obtaining a 15.243(1)(a) for the child. 15.243(1) stated that the only time she felt that she gave Lee consent to have sex with her was when she was extremely 15.243(1)(a) and 15.243(1) 15.243(1) stated that even during this time, Lee was manipulating her and targeting her when she was emotionally vulnerable.

15.243(1) stated that in their religion, it is normal practice to view men as authoritative and abide by their demands. 15.243(1) also stated that in their culture, it is typically prohibited to get police involved in any matter. 15.243(1) stated that it is typical for their society to enforce their own sanctions to sexually deviant individuals. 15.243(1) stated that for these reasons, she was groomed and manipulated by Lee from the time she was 15.243(1)(a) to perform sexual acts, which began as sexual contact and developed into sexual 15.243(1)(a) over time. 15.243(1) stated that she told Lee "no" numerous times, yet continued to make her feel that he would not take no for an answer. 15.243(1) stated that she was mentally and emotionally coerced by Lee and did not have a consensual sexual relationship with him.

15.243(1) is currently staying at a safe location with her friend 15.243(1)(a) to keep herself away from Lee. 15.243(1) stated that Lee is currently in Miami, Florida.

WITNESS STATEMENT 15.243(1)(a)

I made contact with the original caller, 15.243(1)(a) stated she was also formerly associated with the 15.243(1)(a) 15.243(1)(a) in Michigan and has witnessed other women and children be groomed, manipulated, and sexually assaulted by authoritative figures within the church. 15.243(1) stated that approximately one year ago, she reported this information to Det. Wilt from the Michigan State Police Gaylord Post. 15.243(1) stated several subjects were recently arrested in connection to this incident. 15.243(1) stated Lee has personal relationships with all of these subjects. 15.243(1) stated she has known 15.243(1) since they were children and connected with her because of their shared experience. I advised 15.243(1) to email me the report number(s) associated with the incident that she previously reported. I also reached out to Det. Wilt in attempt to gain additional background and context. I have not received follow-up emails from either 15.243(1) or Det. Wilt at the time of this report.

On 1/10/22, 15.243(1)(a) 15.243(1)(a) came to Lansing Police Operations with her attorney Jamie White for an interview. Due to the jurisdiction changes, MSP Sgt. Nate Groya came from the Gaylord post to assist in the investigation and interview.

This interview was audio and video recorded. This interview was saved into Evidence.com for review. This interview lasted approximately 3 hours.

INTERVIEW WITH 15.243(1)(a) 15.243(1)(a)

MSP Groya interviewed and determined that the incidents that the victim remembered were in the jurisdiction of northern Michigan. The victim (15.243(1)(a) 15.243(1)(a) was unable to tell me a time where she was forced to have sex with Lee Chatfield in the city of Lansing. The victim stated that some of the incidents in Lansing were consensual so she was not able to explain a time where it was not consensual. The victim did indicate that she had sexual relations with the accused on several occasions, which one time occurred in his office of the Lansing Capitol. The victim stated that she may have messages on her cell phone and other cell phones that were at her apartment that she shares with her husband Aaron Chatfield. The victim stated that she would turn the cell phones over for extraction of possible evidence.

CONSENT TO SEARCH:

15.243(1)(a) signed a consent to search of her cell phone that she had in her possession. This form was added to the report. The data was extracted by LPD Analyst M. Johnson.

ADDITIONAL:

I transported the victim to her apartment located at [REDACTED] 15.243(1)(a) [REDACTED] to retrieve any additional cell phones that she used at the time of the assaults. One additional cell phone was retrieved from the address. [REDACTED] 15.243(1)([REDACTED] 15.243(1)([REDACTED] signed another consent to search for the additional cell phone. This form was added to the report.

[REDACTED] 15.243(1)([REDACTED] 15.243(1)([REDACTED] also provided notes that she had taken regarding her assaults. I added the notes to this report for review. MSP Groya was provided with my report. Phone extractions will be provided to MSP Groya when they are completed.
